City Manager Hellyn Riggins introduced the Engineer for the Site Plan, John Gordon. After the last meeting Mr. Gordon researched and studied more about the flood issues. There were many concerns from the Commission about the flooding local roads and on the sides of the roads in the previous meeting. Mr. Gordon revised the plans from having a 100 year to a 10 year after his further research. He stated that he used FEMA calculations to help with the plan. However the Commission was concerned about the grading and how it will affect the area below this grading. Commission believed that it could possibly worsen flooding in the area. Mr. Gordon stated that they plan on using a retention pond to help control damage. Commissioner Greg Fox stated that they need a retention and a detention pond which per the plan that is drawn up as of now does not have the space to do so. Mr. Gordon believes that a way to remedy this problem is to have the buildings closer to the street and perhaps smaller as well to be able to give the space for retention and detention ponds. Discussion was had about perhaps only grading where the buildings will be instead of the entire property. However, Mr. Gordon stated that his client would like to grade the entire property. Mr. Gordon asked the commission to continue discussion of the site plan until the next meeting.
